In accordance with instructions received from **Galmarley Ltd t/a BullionVault**, we have performed an independent inspection and audit of the London Good Delivery palladium bars captioned below and our findings are as follows:

Material : 138 London Good Delivery palladium bars

QUANTITY

A total of 138 London Good Delivery palladium bars.

BAR MARKS/ DESCRIPTION OF BARS

All bars were stamped in accordance with London Good Delivery specifications and were in a sound condition.

STORAGE

The 138 bars were contained on 3 plastic pallets. The pallets were located with a Malca-Amit reference.

INSPECTION

On arrival at the vault, permission was given to inspect the palletised bars.

Each bar was inspected and the marked data compared with the Malca-Amit bar list as published on the BullionVault website on 1st November 2024.

Each serial number, bar mark, fineness and refinery cast mark was recorded and compared with the advised lists. The total quantity of bars were found to be correct and agreed with the bar list.

During our audit inspection, we noted that the bar numbering for 8 items is stamped with a leading zero and 1 item is stamped with two leading zeros which wasn't reflected on the published bar list. These data amendments were discussed with the vault, and the full numbers are annexed to the report.

Each of those bars’ subsequent numbering is correct on the published bar list, and their full numbers, including the leading zeroes, are listed for reference in the annexed report.
