In accordance with instructions received from **Galmarley Ltd t/a BullionVault**, we have performed an independent inspection and audit on the London Good Delivery Gold bars captioned below and our findings are as follows:

QUANTITY

A total of 87 Gold Bars vaulted at Loomis International.

BAR MARKS/DESCRIPTION OF BARS

All bars were found correctly stamped and in a good, clean sound condition.

STORAGE

All 87 gold bars were found stored in a glass fronted cabinet inside the Loomis International Inc. vault in [REDACTED] NY. The vault is equipped with alarms and 24/7 CCTV System. The doors of the storage cabinet were found locked with a padlock (which was unlocked when our Surveyor arrived) to start inspection. The bars were stacked on six shelves sorted by weights and brand. Each shelf was unloaded onto a cart for inspection and photographs. After the bars from each shelf were verified, the bars were returned to the same shelf. This process was repeated for each shelf. The cabinet was closed and padlocked at the conclusion of the inspection before the inspector's exit.

INSPECTION

On arrival at the vault, permission was given to inspect and photograph the bars in the vault. Each bar was inspected, and the marked data compared with the Loomis International Weight list dated 2nd November 2022 and the Galmarley Ltd t/a BullionVault list published on 2nd November 2022. Each serial number, bar mark, fineness and refinery cast mark were recorded and compared with the advised list.
