## QUANTITY

A total of 748 London Good Delivery gold bars.

#### BAR MARKS / DESCRIPTION OF BARS

All bars were stamped in accordance with London Good Delivery Gold specifications and were in a sound condition.

### STORAGE

The 748 bars were contained in a metal cage. Each tier of the metal cage was labeled with a Brinks reference number.

#### INSPECTION

On arrival at the vault, permission was given to inspect and photograph the bars.

Each bar was inspected and the marked data compared with the Brinks Master Stock Bar List and the Galmarley Ltd t/a BullionVault list published on 2<sup>nd</sup> November 2022.

Each serial number, bar mark, fineness and refinery cast mark was recorded and compared with the advised lists.

The total quantity of bars were found to be correct and agreed with the Galmarley Ltd t/a BullionVault list and the Brinks Master Stock Bar Lists.
