In accordance with instruction received from **Galmarley Ltd t/a BullionVault**, we have performed an independent inspection and audit of the London Good Delivery Silver Bars captioned below and our findings are as follows:

Material : 2,349 London Good Delivery Silver Bars

Inspection/Audit date : 9th & 10th November 2022

QUANTITY

A total of 2,349 London Good Delivery Silver Bars.

BAR MARKS/ DESCRIPTION OF BARS

All bars were found in a good, sound condition. A total of 2,337 were of London Good Delivery Silver standard; on the other 12 bars, their stamped markings were not consistent with LBMA requirements.

STORAGE

The 2,349 bars were contained on a total of 61 wooden pallets. Each pallet was labelled with a Loomis pallet reference number.

INSPECTION

On arrival at the vault, permission was given to inspect and photograph the palletised bars.

Each bar was inspected, and the marked data compared with the Loomis Master Stock Bar List and the Galmarley Ltd t/a BullionVault list published on 9th November 2022.

Each serial number, bar mark, fineness and refinery cast mark was recorded and compared with the advised list.

The total quantity of bars was found to be correct and agreed with the Galmarley Ltd t/a BullionVault list and the Loomis Master Stock Bar Lists.

During our audit inspection, we noted that the stamped markings on 12 bars were not consistent with current LBMA Good Delivery requirements. We also noted that 76 further data amendments were required. Both are annexed to the report.

REMARKS

- We confirm the sound and secure presence of the 2,349 bars which corresponds with the bar list published 9th November 2022 on the BullionVault website.
- We confirm that the 76 data amendments required were made to the Bar List published 3rd January 2023.
- We also note that the updated list confirms that the 12 bars whose stamped markings were inconsistent with LBMA Good Delivery requirements have been removed.

- Digital photographs of the bars were taken and forwarded to the client.
- To the best of our knowledge, the working conditions and the behaviour and appearance of employees were consistent with, and appropriate for, the nature of the work and was similar to those in other professional vaults we have attended.
