In accordance with instructions received from **Galmarley Ltd t/a BullionVault**, we have performed an independent inspection and audit of the London Good Delivery Gold bars captioned below and our findings are as follows:

QUANTITY

A total of 85 Gold Bars vaulted at Loomis International.

BAR MARKS/DESCRIPTION OF BARS

All bars were found in a good, clean sound condition.

STORAGE

All 85 gold bars were found stored unsorted as per brands or fineness on two shelves in a steel storage closet at Loomis International Inc. vault in [REDACTED] NY. The vault is equipped with alarms and 24/7 CCTV system. The front doors of the closet / cage were found to have a padlock (which was unlocked when our Surveyor arrived) to start the inspection. At the conclusion of our inspection our Surveyor waited until all 85 bars were returned to the closet / cage and a LOOMIS employee re-locked it with the padlock.

INSPECTION

On arrival at the vault, permission was given to inspect and photograph the bars in a designated inspection area. On completion of the audit the bars were returned to the closet in the vault. Each bar was inspected, and the marked data compared with the Loomis International Weight list dated 11th November 2020 and the Galmarley Ltd t/a BullionVault list published on 11th November 2020. Each serial number, bar mark, fineness and refinery cast mark were recorded and compared with the advised list. The total quantity of bars was found to be correct and agreed with both the Loomis Weight list and Galmarley Ltd t/a BullionVault list published on 11th November 2020.
